Updates on contract changes:

- 1. Evidence-Based Prevention Programs contract: overseen by Jennifer Lefeber, longstanding contractor to Aging Services. Ms. Lefeber joined the staff of the Area Agency on Aging and so the work conducted under contract for Evidence-Based Prevention Programs for Older Adults is now done directly by staff.
- 2. The contract to support chore services: HOME (Household & Outdoor Maintenance Engagement) is sunsetting.
- 3. Multiple Meal site supervision: Because of reductions in service locations, the Multiple Meal Site Supervision contract is being reduced.
- 4. Multicultural Senior Socialization: Demand at this site, which also provides the food purchases and catering internally for diners has been growing and so this contract is being recommended for increase.
- 5. Services to Older Asylees and Refugees: This contract went through a Request for Proposal process, and began services in July 1, 2025. The 2025 contract value was prorated for a half year of service provision.
- 6. Two contracts currently held by United Community Center, "Social Programming and Nutrition Programs at the United Community Center" and "Transportation services" are being RFP'd and as Spanish-speaking Senior Center will be RFP'd for an annual value of up to \$350,000 annually. The values in the table above are prorated to support the current contracts with United Community Center being extended for the first quarter of 2026.

These contracts went through a competitive Request for Proposal process in late 2025.

The decrease in Legal Services funding is caused by using federal Medicare outreach grant funds previously allocated to this program to enhance our internal Medicare Outreach Specialist program.

The decrease in Milwaukee County Senior Center programming funding is caused by a reduction of \$200,000 in one time tax levy funds available in 2025 plus a \$115,333 reduction in regular tax levy funding offset by an increase of \$121,139 in IIIB funds.

Caregiver Support programs, which are conducted through Milwaukee County staff:

Caregiver Support Programs:

- AFCSP: \$407,584 for grants to caregivers and programming; \$88,141 for staff salaries.
- NFCSP (Title IIIE): \$312,500 for grants to caregivers and programming; \$188,962 for staff salaries and administrative support.

Milwaukee County Caregiver Support Program: Facilitates the National Family Caregiver Support Program and Alzheimer's Family and Caregiver Support Program in Milwaukee County. Staff facilitate or connect family caregivers to services required under these programs which include: public information/outreach, information and assistance, respite, supplemental services, caregiver counseling, caregiver training, and support groups. Services include direct financial support to family caregivers in the form of grants.

Catering for the Senior Dining Program comes from the following caterers, who are paid through a Fee for Service contract for each meal served.

The catering budget for 2026 includes: \$ 1,272,827 for congregate meals and 1,589,927 for home delivered meals which will be divided based upon meal counts between the following caterers with estimated allocations:
