- A. Approval of this resolution would authorize the abolishment of 1.0 FTE Deputy Sheriff Captain position (Pay grade NR31E) in 4002, Administration and the creation of 1.0 FTE Business Intelligence Analyst (working title Crime Analyst) position in 4052, General Investigations.
- B. Funding for the Crime Analyst position is from budgeted funds for the Deputy Sheriff Captain position which is vacant in 4002 Administration. The total cost for the 1.0 FTE Crime Analyst is \$79,713 including social security starting pay period 1, 2025. Total budget for 1.0 FTE Deputy Sheriff Captain position is \$125,771 including social security.
- C. The 2025 annual salary and social security for the Crime Analyst position is \$79,713 per FTE assuming an hourly rate of \$35.60 in pay grade NR27. The Crime Analyst position would be funded by abolishing 1.0 FTE Deputy Sheriff Captain position.
- D. Assumptions include salaries and social security in 2025 as of pay period 1 for the Crime Analyst position.
