3 Requesting approval to abolish 1.0 FTE Plumber position, pay grade 5417 and create 1.0
4 FTE Plumber Supervisor position, pay grade 5419, by recommending adoption of the

9 WHEREAS, the 2023 Adopted Budget includes two funded Full-Time Equivalent
10 (FTE) Plumber positions, and currently there is one funded position that is vacant; and
11

12 WHEREAS, the Community Reintegration Center (CRC) is the City of Franklin’s
13 largest water consumer, and leadership has determined that it has become necessary
14 to have a position in charge of the Plumbing unit of the CRC Maintenance Department;

17 WHEREAS, the FTE Plumber Supervisor position exists in other Milwaukee
18 County (the County) departments with like duties; and
19

20 WHEREAS, the requested creation of one FTE Plumber Supervisor position is
21 intended to standardize positions, and address equity issues within the County; and
22

23 WHEREAS, the creation of one FTE Plumber Supervisor position will accurately
24 align the position with the responsibilities and the duties it is assigned, and will better
25 address the needs of the CRC; and

27 WHEREAS, the Department of Human Resources has reviewed this position
28 change request, has determined the appropriate classification (Plumber Supervisor) and
29 pay grade (5419), and has submitted a report included in this file; and

31 WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this
32 request with respect to need, appropriateness, and funding availability as required by
33 Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this
34 file; and

36 WHEREAS, the Committee on Personnel, at its meeting of March 7, 2023,
37 recommended adoption of File No. 23-318 (vote 4-0); now, therefore,

39 BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board)

41 in the report hereto attached and summarized below:
