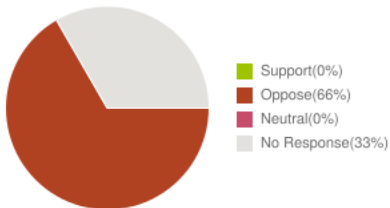

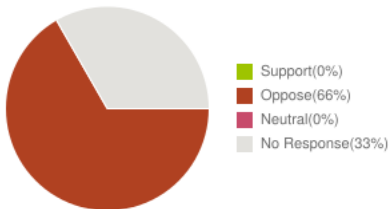

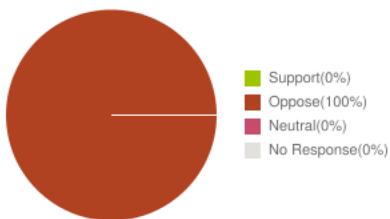

I am a Blind Milwaukee County resident who uses MCTS via Para-Transit and when possible the bus to work, church and other activities.

Recently I had to ask my employer to allow me to work 100% remote due to the problems I encountered with using the van service. I encountered late drop offs, disrespectful and belittling comments from the reservationist and dispatchers over the radio, waiting many times for at least an hour after my scheduled return ride and extremely long travel times to arrive home after working an eight hour shift.

It impacted my attendance at work as well as my performance

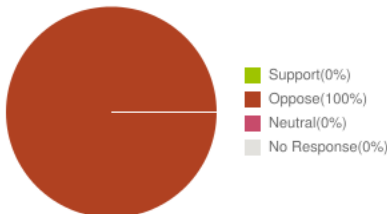
