The Sheriff of Milwaukee County is requesting authority to accept contract funding from the Wisconsin Department of Transportation for a Freeway Services Team (FST) to operate on the Milwaukee County Freeway System for the period of July 1, 2017 through June 30, 2018. The Sheriff's Office will bill the State Department of Transportation on a monthly basis for Deputy Sheriff straight time/fringe benefits and overhead included at \$63.49 per hour and overtime hours excluding overhead of \$56.21 per hour. Contract funds of \$235,000 do not require any matching funds and do not include any equipment purchases.

This contract will not have any impact on the current year budget as expenditures will be absorbed within the operating budget and will be offset by operating revenues.
