 - A. Authorization to accept award by the Wisconsin Department of Transportation (WisDOT) of Federal Surface Transportation Program – Milwaukee Urbanized Area (STP – M) grant funds for an approved Milwaukee County project for bus replacement for the 2021-2022 Grant Period.

This authorization commits Milwaukee County to provide a 20 percent Milwaukee County matching funds requirement when the bus replacement project is undertaken.

- B. The overall direct cost for the STP M bus replacement project approved by WisDOT is \$4,446,900 over the 2021-2022 grant period. The total cost of \$4,446,900 will be offset by \$3,557.523 in federal STP M revenue and \$889,377 in required Milwaukee County matching funds.
- C. The STP M project approved by WisDOT covers the 2021-2022 grant period. As the start date for the approved project is refined, the MCDOT will include the capital project for bus replacement with both the federal and required Milwaukee County matching funds contribution as part of a future request to be approved by the County Board.

² Community Business Development Partners' review is required on all professional service and public work construction contracts.

D. It is understood that by accepting the federal STP – M funds for the WisDOT approved project that Milwaukee County agrees to provide the necessary matching funds contribution in the appropriate budget year when the project is undertaken.

The project award assumes replacement of 8 buses.
