REQUEST

From the Executive Director of Milwaukee County Parks, requesting authorization to enter into a lease extension with the Boys and Girls Club of Greater Milwaukee for their use of the Mary Ryan Building in Sherman Park.

POLICY

§ 59.17(2)(b)3., Wis. Stats., states that the "county board may continue to exercise the authority under s. 59.52(6) with regard to land that is zoned as a park...". In the law of property, authority over "land" include authority over all rights appurtenant to the land.

BACKGROUND

Parks is requesting authorization to enter into a Lease Extension Agreement with the Boys & Girls Clubs of Greater Milwaukee ("the Club") for continued use and operations within the Mary Ryan Building in Sherman Park. This extension supports the Club's long-standing partnership with Milwaukee County, allows for continued youth programming, and enables the Club to pursue capital fundraising efforts for improvements at the site.

Milwaukee County and the Boys & Girls Clubs of Greater Milwaukee have maintained a cooperative relationship at Sherman Park through a Lease originally dated April 30, 1990. The original agreement, formalized under a Lease dated July 1, 1991, included provisions for three (3) ten-year extension terms, contingent on mutual consent.

Since that time, the County and the Club have executed:

- A first Lease Extension on February 22, 2011
- A second Lease Extension on May 6, 2021

Per the terms of the original agreement, modifications may be incorporated into the Lease via written agreement as part of any formal extension.

The current Lease Extension is scheduled to expire on July 1, 2031. The County and the Club have agreed to a third Lease Extension, which would extend the term an additional ten (10) years, through July 1, 2041.

This extension is particularly important as the Club intends to fundraise for capital improvements at Sherman Park. As part of this agreement, the parties have agreed to modify certain terms of the original Lease to clarify roles and responsibilities for site maintenance and upkeep.

Parks recommends approval of the proposed Lease Extension Agreement with the Boys & Girls Clubs of Greater Milwaukee for use of the Mary Ryan Building. This extension will sustain a vital youth service provider in the community, ensure long-term stewardship of the site, and support capital investment efforts to improve the park and facility.

FISCAL EFFECT

With the new amendment terms, Parks will save money as the club assumes responsibility for the mechanical systems. This amendment will decrease parks operating expenses

TERMS

- Ten Year Extension Term (the lease will end in 2041)
- The Clubs utility payment on a yearly basis shall not exceed \$45,955.48
- Club Responsibilities:
 - The Club will be solely responsible for funding, managing, maintaining, and/or supervising all routine maintenance for the newly installed parking lot on the leased premises. This includes maintenance of the pavement, perimeter fencing, dumpster corral, keypad entry system, entry gate, parking signage, snow removal, and adjacent concrete walkways.
 - The Club shall also, at its own expense, provide ongoing janitorial services, routine maintenance, and repairs to all interior components of the leased premises, including mechanical, electrical, and plumbing systems.

County Responsibilities (Parks):

- The County will retain responsibility for structural repairs and restoration work, including the foundation, exterior building elements (windows, doors—excluding the concession roll-up door), roof and flashings, exterior lighting, and utility service connections (water, sewer, electricity).
- Parks will continue maintenance of the splashpad, public restrooms, and the County's designated service and storage areas.
- The Department will make a good faith effort to secure capital improvement funding for larger facility needs, including roof replacement and other exterior infrastructure improvements as defined in the Lease Extension.
