21 22	WHEREAS, the grant award will support community services in ADS, Housing Services, and Behavioral Health Services (BHS), DHHS; and

30 31 32 33 34	WHEREAS, the 2024-2026 grant award will include additional funding primarily for Adult Protective Services, Housing Services (Housing), and BHS, DHHS, for those over the age of 60; and
