Background

Mr. Jim Keegan, Chieff off Planning and Developmentwas ttemporarily assigned into the position off Interim Directtor off the Department off Parkecreatton, and Culture on and granted a TAHC extension on November 14, 2012, which expired on February 12, 2012. In keeping with the spirit off Ordinanta.085, the Department off Human Resources is recommending an extension off the TAHC ffokeagan as the Interim Directtor off the Department off Parkecreatton, and Culture until a permanent Directtor off the Department off Parkecreatton, and Culture has been appointed The Directtor position was recently postted through a search ffrm with an application submission deadline off Aptil2013.

Additionally, Ms. Jill Organ acceptted a TAHC tto the Chieff off Planning and Developmentt leff vacantt by Mr Keegan's TAHC, and Ms. Kurzawa acceptted a TAHC tto the vacantt position off Senior Executive Assistantt tto Interim Directtor Keegan DHR is recommending those TAHCs also be extended until a permanentt Directtor off the Departmentt off ParRecreation, and Culture has been appointed

The Directtor off the Department off Parkecreatton and Cultture is a critical management position responsible ffor the daytoday operations off the department as well as lotterm planning. Since being TAHCed, Ms. Organ and Ms. Kurzawa have capably fflled senior sttaff and support sttaff positions that have helped ensure high quality services continue to be provided to residents off Milwaukee Country have helped maintain the general sttability off the department.
