From the Director, Department of Health and Human Services, requesting authorization to execute Professional Services Contracts with: The Medical College of Wisconsin, Alternatives in Psychological Consultation, Omnicare of Milwaukee, University of Wisconsin Fetal Alcohol Spectrum Disorder Project, Behavioral Affiliates, Inc., Multi-Systemic Therapy, and Norris School District, in the total amount of \$855,200 for a variety of services and programs within the Youth and Family Services Division, for the period effective January 1, 2019, through December 31, 2019, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, per Section 56.30 of the Milwaukee County Code of General Ordinances, the Director, Department of Health and Human Services, is requesting authorization execute 2019 Professional Services Contracts for the Youth and Family Services Division (YFSD); and

WHEREAS, the contracts reflect the procurement of the following services to support both the youth residing in the Detention Center as well as YFSD staff:

- detention physician and medical services and detention psychiatric nursing
- training and technical assistance in the development of a Residential Treatment Center
- a juvenile justice Alcohol and Other Drug Abuse project
- support of youth enrolled in the Milwaukee Accountability Program (MCAP) as well as medical and pharmaceutical supplies and medications

; and

WHEREAS, there is no budgetary impact associated with this request, as funding for these contracts totaling \$855,200 is included in the 2019 Adopted Budget; and

WHEREAS, the Committee on Finance and Audit, at its meeting of December 6, 2018, recommended adoption of File No. 18-860 (vote 7-0); now, therefore,

BE IT RESOLVED, the Director, Department of Health and Human Services, or her designee, is hereby authorized to execute Professional Services Contracts with the following organizations in the total amount of \$855,200, for the period effective January 1, 2019, through December 31, 2019, in the amounts and terms enumerated as follows:
