A RESOLUTION

WHEREAS, the 2022 Adopted Budget provided Milwaukee County (the County) funding for the arts; and

WHEREAS, adopted File No's. 86-466 and 86-463 established guidelines and criteria for awarding County arts funds; and

WHEREAS, adopted File No. 87-732 approved policy guidelines and funding criteria for arts program funding; and

WHEREAS, adopted File No. 21-90 approved updated policy guidelines and funding criteria for arts program funding, in accordance with 2021 Adopted Budget Amendment 1A020; and

WHEREAS, adopted File No. 22-439 adopted a freeze of the proposed funding transition approved in File No. 21-90; and

WHEREAS, the Cultural, Artistic, and Musical Programming Advisory Council (CAMPAC) has reviewed and evaluated applications and comments and has made recommendations for awarding grants through the County arts program; and

WHEREAS, the recommended 2022 CAMPAC allocations were based on the format established in File No. 21-90 and revised in File No. 22-439; and

WHEREAS, CAMPAC met on September 19, 2022, and recommended allocations for approval by the Milwaukee County Board of Supervisors; and

WHEREAS, the Committee on Parks and Culture, at its special virtual meeting of September 21, 2022, recommended adoption of File No. 22-1033 (vote 3-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Director, Department of Parks, Recreation, and Culture (DPRC), to award the following agencies funding in 2022, for the amounts listed, as approved by the Milwaukee County Cultural, Artistic, and Musical Programming Advisory Council:
