The Clerk of Circuit Court is requesting permission to enter into a professional agreement with Credit Management Control (CMC) for collection of unpaid fines, fees, forfeitures, as well as restitution due to crime victims. The duration of the contract is from June 1, 2016 through May 31, 2018. A fiscal impact is not anticipated as the fees earned by CMC would be absorbed from the funds collected by the agency, thus reducing the amount of monies forwarded to the Clerk of Circuit Court as a result of satisfying the debt. There are multiple commission rates in relation to the contract. If payment is made to CMC, the commission is 13%. If payment is made to Clerk of Circuit Court the commission is 11%. If payment is derived from TRIP (Tax Refund Intercept Processing) the commission is 6%. There is no commission on recovered restitution fees.
