# **REQUEST**

A report from the Director, Department of Health and Human Services, requesting approval to create 1.0 FTE Child Support Administrator in paygrade 902E and abolish 1.0 FTE Budget CSS Unit Director in pay grade 901E.

# **POLICY**

The maximum number of positions and/or the maximum number of employee hours in a given classification are approved as part of the annual adopted budget. Changes to the authorized number of positions outside of the budget process require approval by the Milwaukee County Board of Supervisors.

#### **BACKGROUND**

The 2024 Adopted Budget integrated the Milwaukee County Child Support Services (CSS) with the Department of Health and Human Services. The purpose of the integration is to enable greater access for DHHS customers to a broader array of services and encourage a child and family-centric approach to service delivery.

The major responsibilities for the Child Support Administrator position are to provide leadership and support policy direction, programmatic and fiscal management, staff supervision, research and analysis of data, budget development, procurement of services, development of cooperative alliances with outside agencies and adherence to state and federal laws; as well as ensure a comprehensive delivery of child support services and strong connection to the community. The new position would be offset by the abolishment of the CSS Unit Director

included in the 2024 Budget. The proposed classification and pay range for the Child Support Administrator better aligns with administrators who oversee the other service areas in DHHS.

## **ALIGNMENT TO STRATEGIC PLAN**

The request to create a new position in the DHHS aligns with the county's strategic plan to ensure that we can continue in determining what, where, and how we deliver services to advance health equity.
