Unless otherwise modified or extended by 3 4 mutual agreement of the parties, this Agreement shall expire on December 31, 2015. 5 6 PART 2 7 8 2.01 WAGES 9 Effective Pay Period 14, 2015 (June 21, 2015), the wages of bargaining unit employees shall be 10 increased by one and one-half percent (1.5%). 11
