

AMENDMENT TO PROFESSIONAL SERVICE CONTRACT

This Third Amendment to a Professional Service Contract ("Amendment 3") between Milwaukee County, a Wisconsin municipal body corporate, as represented by its House of Correction (hereafter called the "County" or "HOC"), and Employ Milwaukee Inc. (hereafter called "Contractor") is entered on _____. Together these named entities constitute the Parties ("Parties") to this Agreement.

WITNESSETH:

WHEREAS, HOC and Contractor are Parties to that certain Professional Services Contract dated August 1, 2017 (the "Contract") for Re-entry Coordination to help offenders plan for reintegration into the community, focusing on employment and training; case management; and assessments. The contract allowed the County two (2) optional calendar year extensions for 2018 and 2019. The first optional extension (the First Extension) was exercised that extended the Contract to December 31, 2018 in order to be able to continue the program and receive full reimbursement of \$52,000 from a 2016 JAG award. The Contract was increased through the First Amendment on October 3, 2018 from the original \$52,000 to \$74,000 to pay for services through December 31, 2018. Around December 2018, the Contract was again increased through the Second Amendment to \$88,000 to pay for and extend the services through March 31, 2019. The parties wish to increase and extend the contract for a third time, pursuant to which Contractor is responsible for the provision of a reentry coordinator for the HOC; and

WHEREAS, it is the desire of the Parties to amend the Contract as more particularly set forth herein.

NOW THEREFORE, in consideration of the terms and provisions contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the Parties hereto, it is agreed as follows:

PROVISIONS:

COMPENSATION: The total compensation shall be increased by a maximum of \$38,000 (from \$88,000 to \$126,000) to pay for the services through December 31, 2019. The House of Correction will compensate off time for Reentry coordinators and case management staff not to exceed 80 hours of vacation time per year. Sick allowances, personal time off and non-HOC related activity off site will not be compensated.

TERM: Extend the contract end date to December 31, 2019.

AUDIT CLAUSE: The Audit and Inspection of Records clause shall be stricken and replaced with the following:

COUNTY RIGHTS OF ACCESS AND AUDIT.

The Contractor, Lessee, or other party to the contract, its officers, directors, agents, partners and employees shall allow the County Audit Services Division and department contract administrators (collectively referred to as Designated Personnel) and any other party the

Designated Personnel may name, with or without notice, to audit, examine and make copies of any and all records of the Contractor, Lessee, or other party to the contract, related to the terms and performance of the Contract for a period of up to three years following the date of last payment, the end date of this contract, or activity under this contract, whichever is later. Any subcontractors or other parties performing work on this Contract will be bound by the same terms and responsibilities as the Contractor. All subcontracts or other agreements for work performed on this Contract will include written notice that the subcontractors or other parties understand and will comply with the terms and responsibilities. The Contractor, Lessee, or other party to the contract, and any subcontractors understand and will abide by the requirements of Section 34.09 (Audit) and Section 34.095 (Investigations concerning fraud, waste, and abuse) of the Milwaukee County Code of General Ordinances.
