

# **Climate Policy & Planning**


File No. 21-389 commits Milwaukee County to achieving carbon neutrality and requests Sustainability Director to develop and administer strategic plan to achieve carbon-neutral County facilities and operations by 2050.

File No. 21-770 ('CA50 Framework') provides guiding principles and roadmap for the County to achieve carbon neutral facilities and operations by 2050.





# **Climate Change & Equity**



Heat Vulnerability - MKE County<sup>2</sup>

- Carbon emissions accelerate & intensify climate change.
- Inner-city MKE has highest heat vulnerability in state (see map)<sup>1</sup>.
- Extreme heat disproportionately impacts vulnerable groups<sup>2</sup>.
- Extreme heat days in WI projected to triple by 2050<sup>3</sup>.

Climate change impacts community health equity.



# **CA50 Guiding Principles**

1. Create Intentional Inclusion

1a: Identify and involve Milwaukee County stakeholders and partners in each phase of the plan.

1b: Increase involvement of minority and women-owned businesses with plan implementation.

2. Bridge the Gap

2a: Identify health disparities caused by climate change and prioritize actions that will positively impact health outcomes. 3. Invest in Equity

3a: Align actions with Milwaukee County's mission, priorities, and core functions.

3b: Prioritize actions that will provide green education and jobs for underserved communities.

3c: Improve ability of vulnerable communities to adapt to climate change.










- Consultants applied downscaled models to project climate hazards in Milwaukee County under 'high' and 'low' emissions scenarios.
- With climate change, county residents and businesses could increasingly face these hazards:
  - Heat waves
  - Flooding
  - Poor air quality
- Climate vulnerability correlated w/ social vulnerability\*

\*Assessment uses **modified** social vulnerability index based on a similar product from U.S. Centers for Disease Control (CDC) and Agency for Toxic Substances and Disease Registry (ATSDR). See Fig. 2 of report.








