5 **AN AMENDED AND ENGROSSED RESOLUTION**  
6

7 Authorizing and directing the Department of Health and Human Services Division of  
8 Children, Youth, and Family Services to work in conjunction with the Department of  
9 Administrative Services - Information Management Services Division to develop a Youth  
10 in our Care data dashboard

13 WHEREAS, the Department of Health and Human Services Division of Children,  
14 Youth, and Family Services (CYFS) is tasked with providing community-based  
15 alternative programming services for youth involved in the justice system, youth justice  
16 reform, management of the juvenile detention center, and more; and  
17

18 WHEREAS, the census at Vel R. Phillips Detention Center has gradually  
19 increased since September 2021 and recently peaked at 141 in February 2022,  
20 compared to an average census of 89 over the last ten years (File No. 22-423); and  
21

22 WHEREAS, in 2019, the average length of stay in youth detention was 22.5  
23 days; in 2020, it was 34.6 days; in 2021, it was 36.4 days and most recently, in 2022,  
24 the average length of stay increased to an unprecedented 60.3 days; and  
25

26 WHEREAS, the Milwaukee Journal Sentinel reported that in 2021 the Milwaukee  
27 Police Department arrested 926 juveniles compared to 732 in 2019, and 761 in 2018,  
28 and the majority of the arrests were for vehicle theft, reckless driving, fleeing officers,  
29 and other related crimes; and

30 WHEREAS, Milwaukee County has made diligent efforts to alleviate the  
31 increased detention center census through ongoing discussions with court partners and  
32 reviewing youth cases assigned to the Milwaukee County Accountability Program  
33 (MCAP) who are nearing completion; and  
34

35 WHEREAS, the rising census of youth in detention warrants a need to dismantle  
36 silos and share transparent, de-identified information with policymakers, stakeholders,  
37 and the public relating to the youth in our care; and  
38

39 WHEREAS, creating a "Youth in our Care" dashboard will provide information  
40 pertaining to the number of youths housed at Vel. R. Phillips Detention Center, the  
41 number of youths enrolled in the MCAP program, the number of youths waitlisted for the

42 program, the number of youths housed outside of Milwaukee County, and the number of  
43 COVID positive youth; and

45 WHEREAS, Milwaukee County Board of Supervisors adopted File No. 20-174 to  
46 create Chapter 108 of the Milwaukee County Code of General Ordinances relating to  
47 achieving racial equity to improve the health of the entire community by being customer-  
48 focused, improving performance, and equitable practices; and

50 WHEREAS, providing de-identified youth data will show Milwaukee County's  
51 commitment to providing policymakers, parents, guardians, and the community with  
52 qualitative and quantitative data to review and weigh in to improve services for youth in  
53 our care; and

55 WHEREAS, a Youth in our Care dashboard will hold Milwaukee County  
56 accountable for staying on track with achieving its vision to become the healthiest  
57 county in Wisconsin and create transparency surrounding the youth in our care; and

59 WHEREAS, the Committee on Judiciary, Safety, and General Services, at its  
60 meeting of June 10, 2022, recommended adoption of File No. 22-712 (vote 4-0); and

61

62 WHEREAS, the Committee on Health Equity, Human Needs, and Strategic  
63 Planning (HEHNSP), at its meeting of June 17, 2022, laid over File No. 22-712 for one  
64 meeting (vote 5-0); and

66 WHEREAS, the Milwaukee County Board of Supervisors (County Board), at its  
67 meeting of June 23, 2022, referred File No. 22-712 to the Committee on HEHNSP as  
68 amended by the County Board (vote 18-0); and

70 WHEREAS, the Committee on HEHNSP, at its meeting of July 13, 2022, laid  
71 over File No. 22-712 for one meeting (vote 5-0); and

72

73 WHEREAS, the Committee on HEHNSP, at its meeting of September 7, 2022,  
74 recommended adoption of File No. 22-712 as amended by the County Board and  
75 HEHNSP (vote 3-0); now, therefore,

77 BE IT RESOLVED, the Department of Health and Human Services Children,  
78 Youth, and Family Services Division shall work in conjunction with the Department of  
79 Administrative Services Information Management Services Division to develop a Youth  
80 in our Care dashboard; and

82 BE IT FURTHER RESOLVED, the dashboard shall include the number of youths  
83 housed at Vel. R. Phillips Detention Center, the number of youths enrolled in the  
84 Milwaukee County Accountability Program, the number of youths waitlisted for the  
85 program, the number of youths housed outside of Milwaukee County **at Lincoln Hills**  
86 **and Copper Lakes School, Mendota Mental Health Institute, Racine Youthful**  
87 **Offender Correctional Facility, and any other facility of which youth may be**  
88 **housed**, and the number of COVID positive youth; and  
89

90 BE IT FURTHER RESOLVED, the Department of Health and Human Services  
91 and the Information Management Services Division shall present to the Milwaukee  
92 County Board of Supervisors recommendations for implementation of a data dashboard  
93 including, but not limited to, cost to develop and, maintain, where it is sited, and the  
94 aggregate de-identified information that could be provided on the data dashboard no  
95 later than the **January 2023** ~~September 2022~~ meeting cycle.
