IV. UPDATE ON PROGRAMMING AND MEAL SITE SUPERVISION CONTRACT AT THE MILWAUKEE COUNTY SENIOR CENTERS

Jill Knight reported that the intent to award the 2026 contract to Serving Older Adults (SOA) has been sent to President & CEO Michael Van Blaricom. SOA will serve as the contracted provider for 2026, with a possible three-year renewal option. It was noted that the program description will be attached to the 2026 contract.

V. UPDATE ON SENIOR CENTERS

Chair Eugene Guszkowski reported that construction at the Clinton Rose Center, is underway, with a \$4 million upgrade expected to finish in 6-8 months, serving as a test case for its impact on programming and community engagement. Wilson and Washington Park Centers reported only mechanical improvements last year. McGovern is exploring alternative spaces. Under consideration are Embassy Church, Browning School, and Midtown Center which offers over 100,000 square feet and potential accommodations for a library and Election Commission offices. Chair Guszkowski, provided a brief report on a recent meeting with the Kelly/Bucyrus Erie development team to review and discuss the project design.

The committee discussed updates regarding the conversational group and its four subgroups. The group remains in the early stages of organization.
