Request Summary

I respectfully request that the attached resolution, report and fiscal note be scheduled for consideration by the Committee on Finance and Audit at its meeting on March 15, 2018.

The Department on Aging is requesting a fund transfer in the amount of \$655,006 from the Milwaukee County Allocated Appropriation for Contingencies to provide seven months of funding for operations and programming at the five county-owned senior centers from June 1, 2018 through December 31, 2018.

Background

File 17-763, adopted by the Milwaukee County Board of Supervisors on December 14, 2017, authorized the Department on Aging to execute a purchase-of-service contract with Interfaith Older Adult Programs, Inc. in the amount of \$1,122,867 from January 1, 2018 through December 31, 2018. Per the terms of this contract, Interfaith provides a variety of programming options for seniors at the following five county-owned centers: Kelly Senior Center, McGovern Park Senior Center, Washington Park Senior Center, Clinton Rose Senior Center, and Wilson Park Senior Center.

The 2018 Adopted Budget funds senior center operations through June 1, 2018, after which time the contract would be month-to-month through December 31, 2018. The 2018 Adopted Budget provided funding based on the annualized contract amount of \$1,122,867. Of the \$1,122,867 provided for this contract, funding from June 1, 2018 through December 31, 2018 (\$655,006) is in an allocated contingency account within the Appropriation for Contingencies. We ask that the \$655,006 be transferred from the allocated account in the Appropriation for Contingencies to our Department budget so that seniors can continue to have access to operations and programming at the senior centers.

The 2018 Adopted Budget also requested the Department on Aging to provide a report to the County Board by the March 2018 cycle on the feasibility and cost of providing senior center programming with county employees or another contractor beginning June 1, 2018. The 2018 Adopted Budget also required that any plan or contract for senior center programming must require that senior centers are open five days per week, 52 weeks per year.

Senior Center Programming Options

The chart below is a summary of all Interfaith positions currently staffing operations at the five county-owned senior centers, with the exception of the following positions: Volunteer Manager (.25 FTE), Grant Accountant (.1 FTE), and VP Older Adult Services (.05 FTE). Our analysis indicates that it would cost \$1,593,550 for Milwaukee County to provide this same level of staffing coverage with its own employees on an annualized basis – roughly \$470,683 more per year than the current contract with Interfaith.

Our analysis did not take into account the cost of having a different third-party party manage the senior center contract. Our Department's 2018 senior center programming RFP resulted in one bidder (Interfaith), and previous RFP processes coordinated by our Department have resulted in the same outcome. Without having any evidence that there are other vendors with the interest or capacity to contract with the county to provide senior center programming, the only cost comparison that we can make at this point is with county employees.

We have begun exploring the steps that would be needed to execute a Request for Qualifications (RFQ) process. Based on our initial conversations with Department of Administrative Services staff, we estimate that we can complete this process by the end of this year.
