- A. Approval of this resolution will request the WDNR to require that MMSD provide an Environmental Impact Statement (EIS) on the impact and remediation needs related to the removal of the Estabrook; this EIS is to be provided prior to the dam's demolition.

The resolution also requests that MMSD to prepare and provide an EIS on the expected future changes in conditions of the area surrounding and upstream of the Estabrook Dam to the WDNR, the City of Glendale Common Council, and the County Board, regardless of any requirement implemented by the WDNR to provide one.

- B. There are no direct costs associated with this action, as it serves as a request to the WDNR and MMSD to provide information. Existing staff time may be required to communicate the requests.
- C. This resolution has no budgetary impact in the current or subsequent year, and does not require an expenditure of funds.
- D. None.

¹ If it is assumed that there is no fiscal impact associated with the requested action, then an explanatory statement that justifies that conclusion shall be provided. If precise impacts cannot be calculated, then an estimate or range should be provided.
