(WCS) for services at the CRC. The contract will cover the period from July 1, 2025, to June 30, 2028, with an option to extend for up to three (3) additional one-year terms, subject to mutual agreement and satisfactory performance.

POLICY

BACKGROUND

The current contract with Wisconsin Community Services, Inc. (WCS) for the provision of Electronic Monitoring (EM) services is currently on a month-to-month basis and is set to expire on December 31, 2025.

On August 26, 2024, a Request for Proposals (RFP) #2024-004 was issued for Electronic Monitoring Services. WCS was the only respondent to the RFP. After careful evaluation, the proposal submitted by WCS was determined to fully meet all the criteria and requirements outlined in the RFP. As a result, on October 28, 2024, the evaluation panel recommended awarding the contract to WCS.

An award letter was sent to WCS on December 16, 2024, and the execution of this contract is contingent upon approval by the Milwaukee County Board.

Details of the New Contract

Under the 2025 Service Agreement, Wisconsin Community Services, (WCS) was awarded RFP-2024-004 to provide Electronic Monitoring (EM), GPS Monitoring, and SCRAM Monitoring Equipment & Services. This agreement will cover the period from July 1, 2025, to June 30, 2028, with the option for up to three (3) one-year extensions. The contract will provide EM services to residents of the CRC who are eligible for these services.

RECOMMENDATION

The Superintendent of the Community Reintegration Center (CRC) respectfully request the authority to enter into a contract with Wisconsin Community Services, (WCS) for the period of July 1, 2025, to June 30, 2028, with the option to extend the agreement for up to three (3) one-year extensions.
