A 24' wide access easement 12' each side of the described centerline which crosses a part of grantor's premises. located in the Northeast Quarter of Section 29, Township 7 North, Range 21 East, in the City of Wauwatosa, Milwaukee County, Wisconsin, more fully described as follows:

Commencing at the North Quarter corner of said Section 29; thence North 89°42'13" East along the North line of said Northeast Quarter, 1094.72'; thence South 00°17'47" East, 348.38' to the East line of an American Transmission Company transmission line easement and the **Point of Beginning (P.O.B.)** of the centerline of a 24' access easement; thence South 86°45'30" East, 610.23' to the start of a curve to the right; thence Southeasterly 95.75' along the arc of said curve to the right, whose radius is 250.00' and whose chord bears South 75°47'22" East, 95.16'; thence South 64°49'04" East, 31.55' to the start of a curve to the left; thence Southeasterly 78.58' along the arc of said curve to the left, whose radius is 150.00' and whose chord bears South 79°49'34" East, 77.69'; thence North 85°10'01" East, 98.17' to the start of a curve to the left; thence Northeasterly 98.77' along the arc of said curve to the left, whose radius is 71.00' and whose chord bears North 45°19'07" East, 90.99'; thence North 05°28'00" East, 29.18' to the south right of way of Watertown Plank Road and the Point of Ending (P.O.E.) of the above described centerline. Containing 25,000 square feet (0.574 acres) more or less and subject to restrictions. reservation, rights of way and easements of record.

The intent of this access easement is to describe a 24 foot strip of land, the side lines being 12 feet on each side of the above described centerline. Said side lines extending or terminating at the south right of way line of Watertown Plank Road and the easterly line of the transmission line easement as shown on exhibit.

Also a 24' wide access easement 12' each side of the described centerline which crosses a part of grantor's premises, located in the Northeast Quarter of Section 29, Township 7 North, Range 21 East, in the City of Wauwatosa, Milwaukee County, Wisconsin, more fully described as follows:

Commencing at the Point of Beginning of the above description also being the East line of an American Transmission Company transmission line easement; thence South 04°50'57" West along said east line of a transmission line easement, 363.65'; thence South 13°59'34" East along said east line of a transmission easement, 375.34'; thence South 20°22'40" East along said east line of a transmission easement, 82.88' to the Point of Beginning (P.O.B.) of the centerline of a 24' access easement also being the start of a non-tangent curve to the left; thence **Southeasterly** 87.72' along the arc of said curve to the left, whose radius is 181.51' and whose chord bears South 50°27'43" East, 86.86'; thence South 63°49'41" East, 19.28' to the start of a curve to the right; thence Southerly 24.93' along the arc of said curve to the right, whose radius is 17.00' and whose chord bears South 21°40'01" East, 22.76'; thence South 20°11'39" West, 79.47' to the aforesaid east line of a transmission line easement and the Point of Ending (P.O.E.) of the above described centerline. Containing 5,150 square feet (0.118 acres) more or less and subject to restrictions, reservation, rights of way and easements of record.

The intent of this access easement is to describe a 24 foot strip of land, the side lines being 12 feet on each side of the above described centerline. Said side lines extending or terminating at the east right of way line of USH 45 and the easterly line of the transmission line easement as shown on exhibit.
