A. From the Executive Zoo Director, requesting retroactive authorization to enter into the First Amendment to the 2021 Holiday Lights Agreement with RWS Entertainment Group to exercise the first extension from March 1, 2022, to February 28, 2023, not to exceed \$200,000 during that first extension, resulting in a \$350,000 total contract value.

B. The 2022 Adopted Budget includes \$852,550 in expenditures and \$1,449,385 in revenues for the Wild Lights event which is held on 25 nights in the month of December. The increased cost of \$50,000 is absorbed within the Wild Lights expense budget and does not increase the overall cost of the event. The cost of the second contract extension will be included in the 2023 Budget.

C. The Wild Lights event was an initiative started in the 2021 to generate additional revenues and will continue on an annual basis. The event in 2022 is projected to generate a profit of \$596,835. The increased cost is absorbed within the Wild Lights expense budget and does not increase the overall cost of the event.
