Implementation of Wisconsin Statutes 59.21(31) with regard to purchase of professional service agreements (under the Milwaukee General Ordinance Chapter 56) for Capital projects requires County Board passive review for award the initial agreement, or fee extension(s) to the original agreement, when the total contractual fee exceeds \$100,000 but is less than \$300,000.
- B. This fee increase, including design contingencies, results in a not to exceed total fee of \$108,473.75 for the professional services agreement to Short Elliott Hendrickson, Inc. for design services for capital project P714-20179, Kinnickinnic River Parkway – Jackson Park Drive
- C. The adopted 2021 capital budget was for design only with a capital appropriation amount of \$253,905. There are sufficient funds in the capital budget to award the requested professional services agreement to Short Elliott Hendrickson, Inc.
