3 A report from the Director, Department of Human Services, requesting the creation of  
4 1.0 FTE Caregiver Support Specialist in Aging and Disabilities Services, by  
5 recommending adoption of the following:

7 **A RESOLUTION**

9 WHEREAS, in 2020, the Wisconsin Governor’s Task Force on Caregiving  
10 recommended that all counties “designate a specific ‘Caregiver Coordinator’ to manage  
11 caregiver program funds with attention to cultural competence” and require the  
12 development of “a marketing plan to increase knowledge of Caregiver and other  
13 programs at the Aging and Disability Resource Center, particularly within underserved  
14 communities;” and  
15

16 WHEREAS, Milwaukee County (the County) acted upon that recommendation,  
17 and designated a Caregiver Coordinator in 2023, with a plan to create an internal  
18 Caregiver Support Program within the Area Agency on Aging, to manage these  
19 programs within the County Unit on Aging for improved coordination, outreach, referrals,  
20 and effective use of the funds available (adopted File No. 22-813); and  
21

22 WHEREAS, administration of these programs and funding required three roles  
23 within the Alzheimer’s Association when the work was being contracted out, and the  
24 program plan developed by the Caregiver Support Coordinator will require the addition  
25 of a Caregiver Support Specialist in Aging and Disabilities Services, Department of  
26 Health and Human Services, to effectively and efficiently support caregivers in the  
27 County; and

29 WHEREAS, the Department of Human Resources has reviewed this request for  
30 a new position for additional staffing, to determine the appropriate classification  
31 (Caregiver Support Specialist) and pay grade (26), and has submitted a report included  
32 in this file; and

34 WHEREAS, the Office of Strategy, Budget, and Performance has reviewed this  
35 request with respect to need, appropriateness, and funding availability as required per  
36 Section 59.60(10), Wisconsin State Statutes, and has submitted a report included in this  
37 file; and

39 WHEREAS, the Committee on Personnel, at its meeting of June 6, 2023,  
40 recommended adoption of File No. 23-613 (vote 5-0); now, therefore,

42 BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board)  
43 hereby approves the classification and pay recommendation for the position as outlined  
44 in the report hereto attached to this file and summarized below:
