REQUEST

Child Support Services (CSS) was awarded a \$4,999,995 contract for five years (\$999,999 per year) to provide Milwaukee Fatherhood (MF) FIRE Project Services for 2020-2025. Child Support requires the assistance of multiple non-profit partners to provide these services. This contract was approved by the County Board under File 20-873 in December of 2020. CSS has contracted with United Community Center (UCC) as an additional non-profit partner to provide these services retroactive to 9/30/23-6/30/24 in the amount of \$99,000. CSS is amending this contract with UCC for an additional \$21,625 for the remainder of Year 4, 7/1/24-9/29/24, for a total of \$120,625.

POLICY

This report aligns to Amendment #1 as part of item #17 under File No. 20-873 which requires an informational report be submitted to the County Board if any changes to partner contract amounts are made. In addition, this report aligns to Wis. Stats. 59.52 (31) for Passive Review Contracts. A passive review report is required for contracts with a value of at least \$100,000 but not more than \$300,000.

BACKGROUND

Due to the inability of current partners to meet the federally established enrollment goals for the operation of the Fatherhood FIRE grant, UCC was added as a non-profit partner, and the unused contracted amounts and enrollment slots were transferred from current partners to the UCC as shown below:
