- A. Approval of this resolution will provide \$9,103,671 in Opioid Settlement Funds for seven proposed projects for Fiscal Years 2026-2028. The projects will address the opioid crisis across Milwaukee County through treatment, harm reduction, prevention, and other strategies.
- B. Approval of this resolution would allocate \$9,103,671 of Milwaukee's Opioid Settlement Award of \$102 million. The Office of the Comptroller projects that Milwaukee County will receive approximately \$53 M in Settlement funding through 2027 based on a disbursement schedule provided by advisors.

- C. Approved County Board Resolution 21-1127 called for the establishment of a segregated Opioid Abatement Account that is not part of the general fund. Costs for these seven projects are anticipated to be incurred effective August 1, 2025, through December 31, 2028. Any unused funds that remain at the end of the year will be carried over to the new year.
- D. No assumptions or interpretations were made when preparing this fiscal note. The County has been provided a payment schedule by the settlement representative. The Office of the Comptroller projects the County will receive up to \$53 million in payments through 2028.
