Background

Pursuant to File No. 22-16, this update is being provided in response to the request that the Wisconsin Counties Association provide information "regarding conditions for continued membership." Information contained in this report was provided by the Wisconsin Counties Association.

WCA Legislative Initiatives

- In June, WCA joined the Milwaukee County Executive's Office in Washington, D.C. to advocate for Milwaukee County earmarks, securing nearly \$20 million in projects for inclusion in the upcoming appropriations bill.
- The July issue of *Wisconsin Counties* magazine was devoted to transit operations and included Milwaukee County on the magazine cover. A priority for WCA in the upcoming 2023-25 state budget will be to work with Milwaukee County to restore transit cuts included in the current state biennial budget.
- Included in the upcoming WCA Legislative Agenda will be a new platform position advocating for counties to be provided the ability to implement a sales tax beyond the current 0.5%. This is consistent with Milwaukee County's legislative initiative seeking an increased sales tax.
- WCA is prioritizing in the next budget additional youth aids funding that will assist Milwaukee County in funding juvenile corrections.
- WCA and Forward Analytics (WCA's research arm) worked with Milwaukee County on a statewide research report in early 2021 detailing the funding challenges of Wisconsin county governments.
- In May, WCA President & CEO Mark O'Connell joined Chairwoman Nicholson and county staff in Milwaukee to discuss Milwaukee County's legislative priorities.
- WCA has coordinated and joined Milwaukee County for meetings with state legislative leaders.

WCA Diversity, Equity and Inclusion Initiatives (DEI)

- WCA is working closely with Milwaukee County on regional meetings to discuss DEI initiatives (see attached). These meetings will be led by Chairwoman Nicholson, Brown County Executive Troy Streckenbach, and WCA.
- WCA devoted its February 2022 *Wisconsin Counties* magazine to DEI efforts. Included in the magazine were highlights of Milwaukee County initiatives.
- The 2022 WCA Annual Conference will include two concurrent sessions specifically covering DEI-related topics.

Other WCA/Milwaukee Initiatives

- WCA is working with financial experts from throughout the country on a securitization program counties can voluntarily join related to the opioid distributor settlement.
- The WCA Legislative Exchange in 2022 included a panel discussion with Mark O'Connell, WisDOT Secretary Craig Thompson, and County Executive David Crowley.
- WCA attended the NACo Legislative Conference in 2022 and attended congressional hill visits with Milwaukee County representatives.
- Given the possible preemption on Chinese-made drones, WCA recently completed a drone survey and is in the process of exploring a drone replacement program for counties and municipalities.
- WCA nominated Milwaukee County Executive David Crowley for the NACo County Leadership Institute in Washington, D.C.
