The County Board's Legislative Liaison is also authorized and directed to communicate these policy positions to State policymakers, agency staff, and other appropriate persons in order to effectuate the outlined policy directives contained in this file.
 - B. An expenditure of funds will not be required to effectuate this resolution, but an expenditure of staff time will be necessary to communicate the legislative positions to state policymakers and other officials. This will primarily be Government Affairs staff time, but may also include departmental staff, depending on the subject matter.
 - It should be noted that this fiscal note does not attempt to quantify the fiscal impacts on Milwaukee County for any of the legislative initiatives contained in the pending proposals. In general, the lobbying positions typically advocate for greater state aid or flexibility in the operation of programs. To the extent any of the legislative positions are achieved, a separate update will be provided by Government Affairs staff quantifying the potential fiscal impact on Milwaukee County.
 - C. This resolution will have no additional budgetary impact, as the personnel costs are already budgeted within each department. As stated earlier, to the extent the legislative positions
