





WellPath has proven to be an inadequate healthcare provider for our community, and it is high time the county reconsiders its partnership with this company. Over the past several years, numerous complaints have surfaced regarding WellPath's inability to deliver timely and quality healthcare services to those who need it most. Patients routinely report long wait times for care, inadequate follow-up on medical concerns, and substandard treatment that jeopardizes their health. This failure to meet basic healthcare standards not only undermines the well-being of individuals but also places unnecessary strain on the local healthcare system.

One of the most concerning issues with WellPath is their apparent disregard for the specific needs of vulnerable populations, including those in correctional facilities or underserved communities. The company's focus on cost-cutting and efficiency has led to understaffing, poor communication between medical staff and patients, and a lack of continuity in care. These factors contribute to an environment where patients' medical concerns are dismissed or neglected altogether.

In addition to the operational issues, WellPath's track record with patient outcomes is troubling. 
There have clearly been ongoing issues with Wellpath, here in Milwaukee and throughout the country. One article about their recent bankruptcy notes that "according to a filing in one lawsuit brought by the family of someone who died in Ventura County Jail in 2022, Wellpath was sued more than 1,400 times in federal courts between 2013 and 2023." It's of course notable as well that this bankruptcy could delay any current and ongoing legal action against them. Another article notes that "three federal judges in Oregon and Washington have ruled against Wellpath after company leaders intentionally destroyed emails they were ordered to preserve for trial." The recent audit report noted time and time again a lack of transparency and accountability. Continuing to work with Wellpath, and continuing to offer increased funding, is only going to contribute to a continuation of these problems, as evading accountability seems to be quite intentional within this company. Alternate healthcare providers must be considered. Transparency and accountability, in the process of identifying and implementing an appropriate alternative, are of course of the utmost importance. Those incarcerated in Milwaukee jails have no say in their access to healthcare. This decision has direct and significant impact on their health, safety, and wellbeing. Continuing to work with and increase funding to Wellpath without exploring other options shows a clear disregard for the rights and dignity of those in custody, including those who have already died in custody in Wellpath's care. It's well past time to consider other options.

After hearing the findings of the audit, which was carried out with zero community input, there is a plethora of work that needs to be done with the Milwaukee County Jail and the Milwaukee County Sheriff's Office.

We have learned that the correctional officers are haphazardly trained and that the MCJ handles mental health issues poorly. With the issues of mental health in the MCJ, it specifically brings an even greater question of who will actually be handling these issues as Wellpath will soon be out of the picture. We deserve so much better in Milwaukee County and these issues won't be resolved unless we hold the Sheriff's Department accountable. The solutions to these problems can't just be resolved by "more staffing" or increasing their budget as we have seen the MSCO burn our tax dollars with their subpar performance.

We at the Milwaukee Alliance demand that there be a town hall involving the County Board, the Sheriff, and the community so the MCSO can be held accountable for their negligence and receive (legitimate) updates on the corrective strategies provided by Creative Corrections' audit. We also demand that the County adopt a policy similar to the City's SOP 575 (footage release for critical incidents) as the best way to start building any sort of trust is transparency.
