If this proposal is adopted, Milwaukee County Parks will be authorized to amend the 2021 Service Agreement with Ozaukee County for final design and development of habitat restoration plan sets for Little Menomonee River Parkway Section 1 in the Area of Concern. An error of omission in the 2022 Extension of the 2021 Agreement failed to account for funding in the amount of \$153,467 for services provided in 2022 and 2023
 - B. No direct costs, savings, or anticipated revenues. The contract is grant funded. The maximum fee for this agreement through the grant is \$252,467.
 - C. Sufficient funds are budgeted because this contract is being paid by grant funding.
 - D. No assumptions or interpretations were used.
