State Budget

Milwaukee County Courthouse Complex

- Gov Evers Proposed Capital Budget (March)
 - \$25M
 - Most funding ever allocated to a county courthouse; critical momentum
- Public Safety Building Tours (12 Total)
 - Partnership between Sheriff, DA, Chief Judge, County Exec, DAS, SBP, and OGA
 - ~50 legislators
 - ~100 external stakeholders

- February 27 + February 28
- County Exec Crowley spoke on a panel with County Executive Farrow and County Executive Doemel regarding the impact of state mandates on our budget.

State Budget

Joint Finance Hearings

- Kaukauna April 2
 - Early education, k-12, higher ed, Creative Economy and Arts Funding; Medicaid, Mental Health Services; Criminal Justice System and corrections; Transportation, Infrastructure, and Environmental; Veterans
- West Allis April 4th
 - Sheriff, District Attorney, County Executive, and Chief Judge advocated for funds to address underfunded public safety mandates, including funding for the public safety building
 - Birth to 3, APS, Youth Aids, Crisis Services, Housing, Mass Transit Aids, General Transportation Aids
- Hayward April 28th
- Wausau April 29th

Next Steps: JFC holds agency briefings, Executive Sessions (larger decisions will occur after LFB produces projections)



Congressionally Directed Spending Requests

- Most successful local government in the state relative to the number of projects awarded funding through the CDS process (2024).
- Success is a result of partnership between department staff, Strategy, Budget, and Performance and Office of Government Affairs.
- Submitted by department staff, reviewed by Office of Strategy, Budget, and Performance, and shared with Congressional delegation by Office of Government Affairs
