The House of Correction (HOC) is requesting that three (3) positions of Human Services Worker (title code 000563020), and one (1) position of Program and Community Coordinator (title code to be determined [TBD]) be created effective June 18, 2017 with no funding. No additional funds are required.

B. Approval of creating these positions will not increase operating expenditures for 2017.

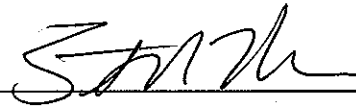
C. Budgetary impact for 2017 is that the position create will not increase operating expenditures, since this is an unfunded request.

D. Cost from the positions will only occur after the grant is awarded. If the grant is not awarded, the positions will not be filled. The DOL grant will pay for the entire cost of the positions. The grant positions will also end with the expiration of the grant period, unless new grant funding is subsequently acquired.
