Approval of this resolution will indicate the Milwaukee County Board of Supervisors approval of the Department of Administrative Services proposed facility plan as outlined in its report attached to File No. 14-483. The Department of Administrative Services will also be required to develop a consolidated facilities strategy outline and submit the outline for review to the Committee on Transportation, Public Works, and Transit for its regular meeting in January 2015.

B. Approval of this resolution will not require an expenditure of funds, but will require existing staff time to develop the consolidated facilities strategy outline. It is expected that any costs to effectuate the facility plan will be included in future budgets or an alternative source of funding will be identified by the Department of Administrative Services.
