Report from the Director, Department of Health and Human Services, requesting authorization to amend 2023 non-professional service contracts by \$125,000, for a total of \$3,210,100, for the Senior Congregate Dining Program, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Milwaukee County Board of Supervisors adopted File No. 22-1110 on December 15, 2022, which authorized the Department of Health and Human Services (DHHS) to execute non-professional service contracts with caterers and minority-owned restaurants to provide nutritious, delicious meals for the Senior Dining Program (the Program); and

WHEREAS, the caterers that provide meals through Aging and Disabilities Services (ADS), DHHS, Senior Meal Program for Older Adults prepare over half a million nutritious and delicious meals for over 5,000 older adults annually; and

WHEREAS, addressing the projected demand for the Program will require an increase of funding of \$125,000 to the catering contracts, and this funding is available through the American Rescue Plan Act’s Older Americans Act (OAA) Title III-C funding; and

WHEREAS, the per meal rates will remain the same as those adopted under File No. 22-1110; and

WHEREAS, consistent with Section 59.52(31)(c), Wisconsin State Statutes, ADS, DHHS, must, on behalf of the Commission on Aging, bring contracts with a value or aggregate value of \$300,000 or more to the Milwaukee County Board of Supervisors for authorization; and

WHEREAS, the Committee on Finance, at its meeting of July 20, 2023, recommended adoption of File No. 23-690 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Director, Department of Health and Human Services, or her designee, to execute an amendment to increase 2023 non-professional catering service contracts by \$125,000, for a total not-to-exceed \$3,210,100, with the providers listed below effective January 1, 2023, through December 31, 2023:
