**A REVISED RESOLUTION**

WHEREAS, per Section 59.52(31), Wisconsin State Statutes, the Director, Department of Health and Human Services (DHHS), is requesting authorization to enter into 2023 Purchase of Service Contracts with community agencies for the Housing Division, DHHS; and

WHEREAS, the contract recommendations are within the limits of the 2023 Adopted Budget; and

WHEREAS, the Committee on Finance, at its meeting of December 8, 2022, recommended adoption of File No. 22-1149 (vote 7-0); now, therefore,
