





Dear County Supervisors, I am writing on behalf of Serving Older Adults, to once again ask for full funding for programming at the five County-owned Senior Centers. With the senior centers temporarily closed to participants, we have had to look for new ways to engage with the older adults in our county who are isolated and lonely during this pandemic. We have created virtual and outdoor programming and continue to check in with participants, to see if they are doing well and have the resources they need, making nearly 15,000 wellness calls since the pandemic began. We have increased outreach through mail, email, and social media, to keep our participants informed and updated. Our meal program has doubled in size and we are now providing over 13,000 meals a month! We are asking you to maintain funding for the senior centers to help us expand our programming to reach even more seniors. We have found that many of our participants do not have access to technology which further increases their isolation. We have a technology plan to provide seniors access to tablets and training, giving them an opportunity to connect with the outside world. Many older adults trust the senior centers to refer them to services they need. The seniors that are served by the centers are diverse in race, background, economic status, culture and religion. More than one third of the seniors who attend the centers are below the federal poverty level. Cutting funding to a vital service for them would be detrimental to our community as a whole. Maintaining or expanding funding for the centers aligns perfectly with the county's vision that by achieving
