Re:	Informational Report – Status and Use of Free Birth Certificate Program		

Background:

The Free Birth Certificate Program (FBCP) was initially passed by the Milwaukee County Board of Supervisors in 2012. It allows Milwaukee County residents to reduce impediments to voting and youth employment by directing the Register of Deeds Office to issue a certain number of free birth certificates to County residents if the resident attests that they are utilizing the birth certificates for the stated purpose of the program and have not previously been issued a free certificate by the Register of Deeds Office. The FBCP for youth jobs is for County residents between the ages of 15 and 21. The Register of Deeds Office is directed to continue to require that residents seeking a free birth certificate under the program complete and sign a form attesting to the purpose of the request and that they have not previously been issued a birth certificate under the program.

In its 2020 Adopted Budget Amendment - 1A001 (Org. Units 3400 Register of Deeds & 1800-1993 State Shared Taxes), the Milwaukee County Board of Supervisors reauthorized the FBCP to allow the issuance of an additional 1,000 birth certificates for voting and youth jobs. The Register of Deeds was requested to provide a report to the County Board of Supervisors no later than the July meeting cycle on the status and use of the program. The total free birth certificates remaining in 2019 were 120. The Board of Supervisors authorized an additional 1,000 in 2020. Thus, the total free birth certificates as of January 2020 was 1,120.

Out of the 1,120 birth certificates available at the start of 2020, 169 were issued that year; 13 were issued in 2021; and 17 were issued from 1/1/2022 to 6/30/23. From 07/01/2023 to 06/30/2024, 13 certificates were issued. The amount remaining under the FBCP as of 6/30/2025 is 908. Please see below:

Budget Impact

In 2020, the County Board of Supervisors authorized \$15,000 for the FBCP. Reports and Funds Transfers are submitted biannually to the State Department of Administration. For each record issued, the ROD Office submits \$15 to the State of Wisconsin as per applicable Wisconsin statutes.

Conclusion

The Register of Deeds Office is fully supportive of the FBCP and encourages Supervisors to promote the program through the Milwaukee County website, newsletters, community events/forums and direct contact with nonpartisan voting rights and youth groups.
