From the Interim Director, Department of Health and Human Services, requesting authorization to execute Professional Services Contracts with: The Medical College of Wisconsin, Alternatives in Psychological Consultation, Behavioral Affiliates, Wauwatosa Virtual Academy, Omnicare of Milwaukee, and the University of Wisconsin-Madison, in the total amount of \$548,070 for programs within the Delinquency and Court Services Division for the period effective January 1, 2018, through December 31, 2018, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, per Section 56.30 of the Milwaukee County Code of General Ordinances, the Interim Director, Department of Health and Human Services (DHHS), is requesting authorization to enter into 2018 Professional Services Contracts for the Delinquency and Court Services Division (DCSD) in the amount of \$548,070; and

WHEREAS, the contracts reflect the procurement of the following services to support both the youth residing in the Juvenile Detention Center as well as DCSD staff:

- detention physician and medical services and detention psychiatric nursing
- training and technical assistance in the development of a Residential Treatment Facility
- a juvenile justice Alcohol and Other Drug Abuse project
- virtual education and support of youth enrolled in the Milwaukee Accountability Program
- medical and pharmaceutical supplies and medications

; and

WHEREAS, there is no budgetary impact associated with this request, as funding for these contracts totaling \$548,070 is included in the 2018 Adopted Budget; and

WHEREAS, the Committee on Finance and Audit, at its meeting of December 11, 2017, recommended adoption of File No. 17-749 (vote 7-0); now, therefore,

BE IT RESOLVED, the Interim Director, Department of Health and Human Services, or her designee, is hereby authorized to enter into Professional Services Contracts in the total amount of \$548,070 with the following organizations for the period effective January 1, 2018, through December 31, 2018, in the amounts and terms enumerated as follows:
