

3 A report from the Executive Director, Department of Health and Human Services,  
4 requesting authorization to execute 2026 purchase of service contracts for the Area  
5 Agency on Aging (AAA), by recommending adoption of the following:

7 **A RESOLUTION**

9 WHEREAS, the Department of Health and Human Services (DHHS), through the  
10 Milwaukee County (the County) Area Agency on Aging (AAA), funds a variety of  
11 services and supports for older adults through service contracts with vendors, in  
12 alignment with the 2025-2027 AAA Plan (the Plan), as approved by the Commission on  
13 Aging (COA); and  
14

15 WHEREAS, the COA exercised its authority to approve these contract  
16 allocations, pursuant to Section 53.09 of the Milwaukee County Code of General  
17 Ordinances, at its meeting of October 24, 2025, and the Milwaukee County Board of  
18 Supervisors (County Board) has the authority to review these allocations and execute  
19 the contracts; and  
20

21 WHEREAS, each of the contracts for services listed below aligns with the Plan,  
22 are within the scope authorized by the Older Americans Act (OAA), and advance the  
23 County's vision for health equity, by providing services upstream that advance health  
24 and wellness for older adult residents in the greatest economic and social need; and  
25

26 WHEREAS, each of the contracts listed below is funded in whole or part through  
27 the OAA, which provides funding to communities to help older adults live independently;  
28 and

30 WHEREAS, consistent with Section 59.52(31)(c), Wisconsin State Statutes  
31 (State Statutes), DHHS must, on behalf of the COA, bring contracts with a value or  
32 aggregate value of \$300,000 or more to the County Board for authorization; and

34 WHEREAS, the Committee on Health Equity, Human Needs, and Strategic  
35 Planning, at its meeting of December 4, 2025, considered File No. 25-747 for  
36 informational purposes only, per Section 59.52(31)(d), State Statutes; and

38 WHEREAS, the Committee on Finance, at its meeting of December 11, 2025,  
39 recommended adoption of File No. 25-747 (vote 6-0); now, therefore,

41 BE IT RESOLVED, the Milwaukee County Board of Supervisors (County Board)  
42 hereby authorizes the Director, Department of Health and Human Services (DHHS), or  
43 her designee, to execute the following purchase of service contracts with the following  
44 agencies and in the amounts listed below, for the period of January 1, 2026, to  
45 December 31, 2026:
