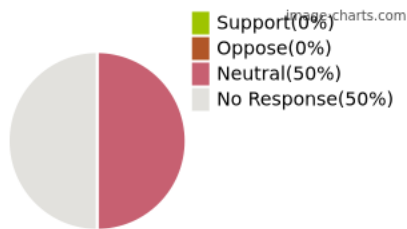

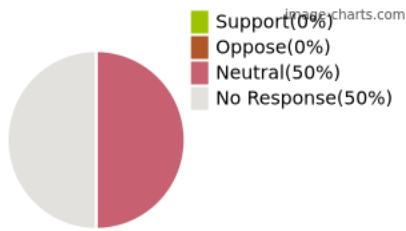

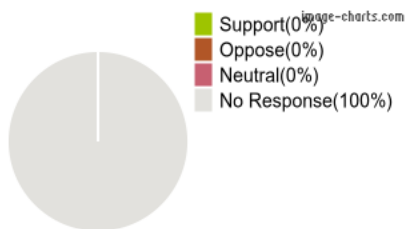

Myself and many neighbors met with Mike Atkins (sound person) and 2 others from the ROC last Wednesday evening for a sound check. During this time Mike stated he had turned the bass completely off and set the volume at the umbrella bar to 80 db. At this sound check the noise was carrying and much louder at and in Dana Gindt and Bernie's homes, while at my home in GREENDALE we could not hear it at all. I must mention the readings Mike was getting were not the actual readings from each home as he does not have the ability to do so at this time, but had readings from the sound monitors. I believe this point is important as the neighbors and police chief have stated the monitors are not affective due to being either too high or too low from the source of the sounds. Explaining why the noise coming from certain areas of the ROC are much louder in certain homes, bedrooms and yards. With that said, this weekend was the first concert at the umbrella bar since the implementation of the speakers and auto limiter. The bass was the worst it has ever been in our home/bedroom. I did reach out to Mr. Atkins who did try some things to rectify the problem from his end, but was unable to do so. He has kept the line of communication open and is going to work on a few things to correct this issue for us. We truly appreciate his cooperation and look forward to working with him to fix this.

To be fair, the noise from the stadium has been so much better due to following the Franklin ordinances. We have been able to have company in our back yard and enjoy our time outside while not having to yell over noise from the ROC. In fact, many of the neighbors have had conversations as to how much they are enjoying their yards again.

While we have accomplished some victories, we have a few more to go. Let us keep this momentum going and work toward a cohesive and respectful relationship.
