# **REQUEST**

The Office of Strategy, Budget and Performance (SBP) requests confirmation of the Milwaukee County Youth Commissioners to represent vacant districts 2, 7, 10, 11, 12, 14 and 16. This item also provides an update on the Milwaukee County Youth Commission program activities and accomplishments.

### **POLICY**

This update is being provided pursuant to File <u>22-662</u>, "To modify Chapter 106 of the Milwaukee County Code of General Ordinances to reestablish the Milwaukee County Commission on Youth and align its priorities with Milwaukee County's mission and vision to achieve racial equity..."

#### **BACKGROUND**

Per file <u>22-662</u> 106.03 – Selection of Commissioners, the "commission on youth will appoint from within its ranks a selection committee of not less than five (5) commissioners". Based on the criteria set in file 22-662, the selection committee unanimously recommended seven Youth Commissioners to fill the vacant supervisory districts and are now requested for confirmation by the Milwaukee County Board of Supervisors as outlined in Table A: Milwaukee County Youth Commissioners Requesting Board Confirmation.

## 2025 Remaining Activities

The Milwaukee County Board of Supervisors and members of the public are invited to attend the closing ceremony December 17, 2025, starting at 5:30 PM to recognize the Youth Commissioners whose term ends in December. The ceremony will also recognize the 2025 Youth Commission operating partner, Safe & Sound, for their significant program contributions as well as the 2025 adult advisors. In addition, the Youth Commission standing committees are finalizing action plans that include the mission of the committee, goals of the committee and outlining necessary activities to achieve the committee goals. As part of the annual budget, the Milwaukee County Board of Supervisors approved funds for the Youth Commission to allocate to service providers and nonprofits. In December, the Youth Commission will approve up to \$35,000 of funds that advance the identified policy areas; youth experiencing housing instability, youth wellness, and civic engagement.
