# **MINUTES**

## SCHEDULED ITEMS:

#### 1. Welcome.

Mary Neubauer, Chairwoman of the Milwaukee County Mental Health Board, welcomed everyone to the June 10, 2025 Milwaukee County Mental Health Board Finance Committee Budget Hearing. She introduced Joy Tapper and noted she is the new chair of the finance committee and Chairwoman Tapper assumed chair of the meeting.

### 2. 2026 Budget Narrative Overview.

Matt Fortman, Fiscal Administrator, presented the 2026 Budget Narrative Overview which was uploaded to CLIC following the public comment meeting. He provided an overview of the budget process and apologized to the committee for being unable to provide an advanced copy of the narrative to the board. He explained how the tax levy limit affects the BHS Budget and indicated based on the budget restraints BHS is forced reduce some non-tax levy funded services. He explained the following major changes:

Total BHS effective tax levy is reduced by \$0.5m in 2026 to account for countywide reductions needed to fund ongoing pension liabilities. State and Federal grant revenue is reduced by \$2.1m primarily due to sunsetting of adult AODA and Youth mental health grants. Wisconsin Medicaid Cost Report (WIMCR) revenue is reduced by \$12.4m. Net Medicaid revenue is reduced by \$2.0m based on ongoing revenue realization experience.

Major expenditure reductions include elimination of Residential Withdrawal Management Services DHS 75.57, and Sobering Center/Residential Intoxication Monitoring Service 75.58 (\$2.9m expense reduction, known colloquially as "Detox" and operated as First Step), elimination of a contracted Community Support Program (CSP) provider, decrease in AODA prevention spending, elimination of BHS' \$1.0m support for Housing First,

	decrease in Youth Mental Health Grant programs, decrease in Youth Crisis Intervention Services of \$4.8m based on ongoing enrollment trends, and elimination of non-mandated tax levy-funded programs in CARS. Major increases include \$0.8m for rate increases for crisis intervention provider agencies that perform coordination services (effective mid-year 2025) and \$0.3m increase for a Comprehensive Community Services rate increase for peer specialists and rehabilitation workers. These increases are offset by increased Medicaid and Wisconsin Medicaid Cost Report (WIMCR) revenue assumptions
	Total BHS staffing is reduced by 33.25 FTE. This includes net 7.25 FTE position eliminations, and 26.0 FTE positions transferred from BHS to DHHS. In addition to the FTE reductions, hourly psychiatrist costs are reduced based on ongoing need.
	Prior to the public comment section, Committee Coordinator Jessica Iggens noted that there were comments indicating that the audience that was connected to the TEAMS meeting and listening virtually could not hear the presentation of the narrative. The recorded audio and minutes will be available on CLIC following the meeting.
