The resolution also urges the Wisconsin State Legislature to enact legislation to implement a requirement for retailers to confirm the age of customers of these products with a photo ID to ensure compliance with the legislation. Milwaukee County Office of Government Affairs is requested to communicate the contents of this resolution to the Governor, members of the Wisconsin State Legislature and the Wisconsin Counties Association.
