

Overall Sentiment







While I'm glad to see allocations being approved, I'm disappointed to learn that the total CAMPAC funds were reduced by 25% in the budget - especially in a state where we already invest so little in arts and culture, and at a time when our society is so full of fear and division. Ex Fabula, whose mission is to connect Milwaukee through the art of storytelling, has weathered challenge after challenge - and still, we're putting on events that build cultural humility and support mental health - like our award-winning Deaf StorySlam and AfterDark: For the Culture events, which center Black and Brown voices. To some, this might seem like "just trimming \$3000" off the 9K we received last year, but to us, it's less money to pay artists. It's fewer events, and thus fewer attendees saying "I felt seen and safe" and "I felt the love and acknowledgement". And at some point, all these cuts may make it impossible to exist at all.

So, thank you for investing in the arts - I do appreciate it - but I wanted to be sure you know that the cut is felt and will have negative consequences. I hope you will take a different path and increase arts and culture funding next year. The City of Baltimore made strategic investments in youth jobs, mental health, violence prevention, and the arts; now, violent crime has decreased there. I would love for us to study and learn from those stories.





Here are my initial comments on the meeting today at the courthouse.

On the Matter of "We have been completely transparent every step of the way." - Milwaukee Public Museum On Tuesday, members of the community were given only a short time to present our concerns about the Milwaukee Public Museum. I would like to follow up on one specific claim that was made: that MPM has been transparent every step of the way and that the public has been fully involved in shaping the museum's future. If that were true, it is important to ask: what questions were the public actually allowed to answer? If the question were: Do you want to preserve Milwaukee County's Public Museum? — the answer would have been a resounding yes.

If the question were: Do you want to add more years of Milwaukee history and cover more stories? — the answer again would be yes.

But if the question had been: Do you want to redesign and transform the museum according to cultural and political trends? — the response would have been far more hesitant.

And if the question had been: Do you want to remove the Streets of Old Milwaukee, abandon the existing dioramas and murals, reduce the European Village to fragments, and replace an immersive public museum with a

building half the size, emphasizing only science and natural history? — the answer would have been very different.

The truth is, the public was never given those choices. In fact, when we submitted an open records request to obtain the actual survey questions asked, our request was denied — despite Wisconsin's open records law promising a "presumption of complete public access".

That is why many in this community do not accept the assertion that this process has been transparent. Requests for information have been dismissed, and public concerns have been described by Dr. Ellen Censky herself as mere "public pushback," not as legitimate input.

Meanwhile, the State of Wisconsin has secured an ownership stake in the new museum as part of its \$40 million contribution. Milwaukee County — which owns the collection and the current building — has committed \$45 million, yet has no comparable ownership stake. That is not transparency, and it is not equity for the taxpayers of Milwaukee County.

The community deserves answers to the questions we were never allowed to answer.
