The Sheriff is requesting authorization to execute a professional services contract to provide primary and emergency veterinary services and care for security canines of the Milwaukee County Sheriff's Office. The Sheriff is requesting a three (3) year contract from January 1, 2017 through December 31, 2019 with two (2) optional one year extensions. Maximum amount to be expended each one year period is \$24,999. If annual expense exceeds the contract amount during any of the one year periods the K-9 Unit Commander must approve any amount exceeding the maximum. The contract will automatically renew unless the Sheriff notifies the Contractor of intent not to renew the contract 90 days prior to the December 31<sup>st</sup> expiration date.
