A Request from the Director, Department of Administrative Services, regarding Passive Review of a Professional Services Agreement exceeding \$100,000 but less than \$300,000 for Capital Project WP068201 – Whitnall Clubhouse HVAC Replacement and Kitchen Improvements.

REQUEST

The Director of Architecture, Engineering & Environmental Services is requesting a passive review to enter into a professional services agreement with Quorum Architecturs Inc. to provide professional services for Capital Project WP068201 – Whitnall Clubhouse HVAC Replacement and Kitchen Improvements.

PROJECT OVERVIEW

The capital project was previously approved and funded at \$167,205 budget for design-only phase. Future construction scope and cost will be submitted for future review and approval. The design will focus on HVAC system replacement for kitchen and dining room to improve conditions for employees and guests. Additionally, other design will include improvements to kitchen layout, kitchen equipment, and its associated electrical, mechanical, and plumbing systems, and ADA code compliance ramps and restroom. The County's VFA database reflects the need for upgrades and repairs of this nature, as the building systems and areas described are categorized as potentially critical repairs.

The project is being funded as part of the Milwaukee County Capital Improvement Plan (CIP).

The capital budget includes funding for design only. A passive review of the proposed Quorum Architects, Inc. consultant agreement is requested.
