The Economic Development Director is requesting authorization to apply and accept an ISR grant of up to \$200,000 from WEDC in partnership with UEC and pass along grant funds to UEC for their Riverland Development Project. UEC is entirely responsible for compliance with all terms of the grant; they just need a government partner to apply for, accept, and implement their application with WEDC.
  - B. If the project is completed by the Urban Ecology Center, proceeds up to \$200,000 would be received by County and then paid out to UEC.
