# **BACKGROUND**

This report serves as an update to File and Resolution 25-427 from the June 2025 cycle. The Resolution requested DAS-IMSD to coordinate with relevant stakeholders in development of a countywide policy addressing the use of facial recognition technology (FRT). This report and associated presentation are to provide the requested December 2025 update.

During the Committee on Finance's meetings for the 2026 budget, discussion included requests for more understanding about the technology used within the County's camera systems. The attached presentation outlines general technical information about artificial intelligence (AI) and its role in FRT. Additionally, the presentation outlines the specific camera technologies the County has and FRT capabilities. At this time, Milwaukee County does not employ FRT, though, MCSO is proposing a possible future use related to photos taken during the booking or arrest intake process.

Lastly, the presentation includes language being considered for the countywide policy for further discussion with the County Board to ensure alignment prior to completion of a final policy.
