




#### Overall Sentiment

Mr. Chair and members of the committee. I am a resident of Milwaukee County District 7 and would like to remind you that a great task remains incomplete. Last year, the Milwaukee County Board passed resolution 23-839. The vote was 15 Aye's, 2 excused, and 1 abstention. Except for the newly-elected supervisors, this committee was in support of the Transit Rangers program. The bus operators and the general public expressed enthusiastic

support of this idea and one person killed it: David Crowley. In his letter dated October 23 2023, he explained that for reasons of "fiscal responsibility" that he would decline to sign the resolution. I respectfully disagree with his conclusions as the Transit Rangers program was a very well-conceived plan to address security concerns AND also to mitigate the issues that may cause them. The relationship with international security conglomerate, Allied Universal, should end. Their business model is to profit off of the social failures of this community while doing nothing to correct their causes. The Transit Rangers program sought to perform the work of keeping buses safe, a task which has been abdicated by the Sheriff's Office, and to connect riders experiencing crisis to the appropriate social service agency, a task related to the Department of Health and Human Services. When viewed in this light, you should see that the Transit Rangers address acute and chronic needs of MCTS riders while Allied Universal's method of security is catch and release. As a taxpayer, I do not want to add to the wealth of a privately owned security firm with locations in 90 countries and a revenue of \$20 billion dollars. I am in favor of directly employing Milwaukeens to take care of Milwaukee. Please revisit file number 23-839, update the appropriate information and let's give David Crowley the opportunity to correct the mistake he made in October.
